Dear Applicant,

According to the [World Bank list of Economies](#) (list as of June 2020), candidates are divided into the following income groups, based on their citizenship and residence:

- low income;
- lower middle income;
- upper middle income;
- high income.

If you are a citizen from a **high-income** country, you are not eligible to apply for a scholarship.

Should you be a citizen from a **non-high-income** country, please first check your admission score. You are eligible to apply for a scholarship only if you have been admitted with a **minimum admission score of 80 out of 100**.

In other words, be sure to complete the admission process prior to submitting your scholarship application and, ideally, well in advance of the deadline.

IMPORTANT NOTICE for Stateless or Refugee Students:

These students will be requested to produce only an official statement issued by the Italian Ministry of the Interior or by the Italian Office of the High Commissioner of the United Nations.

STEP 1 - Gather the requested documentation and send your scholarship application

As citizen from a **non-high-income** country, you are requested to send to segreteria@unisg.it the following documents:

- an official affidavit issued by an Italian authority in your home country, such as a Consulate or Embassy, certifying that you are a legal resident of that country, and that you do not come from a high-income background family.
- the scholarship application form (*Attachment 3*).

Please indicate in the object of the email “*Scholarship application, a.y. 2022/2023_Name of the Program*”. Documents must be sent readable and in pdf or word format.

Please note that the completed scholarship application must arrive in digital format by the deadline indicated on the scholarship public announcement. Late delivery of documents will not be accepted.

The University can request further documentation to control the truthfulness of the affidavit submitted.

STEP 2 - Publication of the Scholarship Ranking list

The final list of students awarded fee exemptions will be published on the University’s website (www.unisg.it) on the date indicated in the scholarship announcement.

STEP 3 - Provide the translated and certified affidavit

ONLY if you will be assigned a scholarship will we ask you to have your affidavit translated into Italian by a translator approved by the Italian consular authorities nearest your place of legal residence. After being translated, the Italian consulate must certify that the document was issued by the appropriate local authority and that the translation accurately reflects the contents of all supporting documents.

Considering that the process of requesting consular legalization for scholarship documents may be time-consuming, the Italian translation, which must be certified by Italian consular authorities, may be received following the aforementioned deadline, provided that it arrives before the start of your program.
